Motion by Rost, seconded by Jerzak to designate Superintendent Dan Deitte with the authority to authorize user access to MDE secure websites with the responsibility of assigning job duties to local education agency staff through June 30, 2022 M/P/UC
Motion by Landrus, seconded by Popowski to approve the resignation of Dan Deitte, Superintendent, effective at the end of the day June 30, 2022. M/P/UC
