- III. Motion by Popowski, second by Kiley to approve the October 12, 2022 meeting minutes. MC
- IV. Motion by Landrus, second by Kiley to accept the financial report and payment of bills. MC
- V. Mr. Woelber updated the board on election results and discussed the different precinct results and various demographics of the district.
- VI. Report by Principal Lindeman on Staffing updates, Title updates, early childhood screenings, teacher observations, photo restoration in hallways and musical attendance in Minneota.
- VII. Report by Superintendent Woelber on goals after the election, ongoing budget meetings with the Service Cooperative, buildings and grounds updates and the planning for 2023 - 2024. Mr. Woelber also thanked the anonymous donor(s) that put up the Lincoln elementary billboard west of town.

- X. Motion by Kiley, second by Popowski to approve the teaching contract for Olivia Gasca to begin on or about January 2 of 2023 and a paraprofessional contract for Olivia Gasca to begin November 15, 2022 through December of 2022. MC
- XI. Motion by Landrus, second by Popowski to approve the annual seniority list. MC
- XII. Motion by Rost, second by Landrus to approve the annual WBWF report and summary. MC
- XIII. The board and administration discussed the prior work on starting a daycare to add to the before and after school program that was in operation at the school prior to the pandemic. There is interest in getting all that back into the school. Mr. Woelber will begin the planning.
